

## **Orion Energy Systems Appoints Executive Vice President of Operations**

The addition of Gaumer will enable Michael Potts, P.E., Orion's President, to better focus his efforts on high-level business development activities at Orion. These activities include a key strategic goal for Orion in selling directly to utilities, by convincing them of the economic and social benefits of investing in energy efficiency improvements on the customer side and still putting it in the rate base like a traditional investment. Potts will also focus his efforts on expanding Orion's presence with large national customers, including building upon the 130 Fortune 500 customers already served by the Company.
