## **Orion Energy Systems VP Featured At Carbon Finance Forum**

### **Heins Joins Other Experts in Discussion of U.S. Cap-and-Trade Possibilities**

MANITOWOC, Wis., Sep 18, 2008 (GlobeNewswire via COMTEX News Network) -- Steve Heins, vice president of communications and governmental affairs for Orion Energy Systems Inc. (Nasdaq:OESX), will be a featured speaker at the U.S. Carbon Finance Forum, which is set for Sept. 24-25 in New York City.

The second annual conference will unite investors with representatives from finance, industry and government bodies, to examine how carbon legislation will affect stakeholders in the U.S. and to identify existing opportunities in carbon markets worldwide.

Key topics of the forum include crucial foundations for a U.S. cap-and-trade market, expansion of carbon trading to a full suite of carbon products and the chain reaction in the energy market and regulatory changes that will follow. Heins will discuss the barriers to energy efficiency deployment and the barriers to properly certified energy efficiency projects qualifying for emission trading. Heins said the conference will entail a "robust discussion of energy as it relates to emission reductions and trading nationally."

"I'm thrilled to be presenting at the second annual U.S. Carbon Finance Forum," Heins said. "Now that it looks like we're going to have a serious discussion about a regional and national cap-and-trade market, Orion believes energy efficiency should be one of the first opportunities for emission reductions and emission trading."

Heins focuses on advocacy and education for Orion, promoting energy efficiency at the local, state and national levels. He is a frequent speaker and has published more than three dozen articles and op-ed pieces related to energy management, the utility industry and environmental issues for leading publications, including the San Diego Union Tribune, Milwaukee Journal Sentinel, Engineering Times, Energy and Power Management, EnergyPulse and Electricity Today.

In addition to Heins, other carbon trade experts speaking at the forum include Sam Napolitano, director of Clean Air Markets for the Environmental Protection Agency; Ken Newcombe, managing director of U.S. Carbon Emissions Trading for Goldman Sachs; and Bruce M. Kahn, director and senior investment analyst, Climate Change Investment Research Group, Deutsche Asset Management.
